## Fire Department Report

Fire Chief Hart reported 21 runs during the month of February. Of the calls, 19 were medical, 1 car fire, and 1 mutual aid with Hubbard Lake building fire. This brings their total to 47 runs this year to date compared to 37 runs last year. Aivee Hoffman is attending an EMT-B class in Atlanta. Chief Hart stated he told Aivee she will be reimbursed for class and book once she passes the class. Members of fire department will be attending a wild fire class at South Shore Fire Department on March10. Chief Hart, Darrick Hart, and Gauthier will attend the pipe line dinner on March 19, 2020. Chief Hart stated Mark Brown from CSI will attend April 13 meeting to discuss new fire truck.

John Kozlowski also stated from previous Ambulance meeting Mark Hall is trying to get EMT classes to be held at Alpena Community College.
