## A) Planning Commission & ZBA

Gauthier read letter from Tammy Sumerix-Bates, Alpena County Board of Commissioners, regarding Alpena County Youth and Recreation 2021 Grant Recipient for the Volleyball Grant Sanborn Township received. Gauthier signed and returned grant agreement to the County Commissioners' Office as requested. Souva emailed current audit information and Lappan Insurance provided a copy of Sanborn Township's liability insurance.

Liske stated paperwork will be sent to Sanborn Township after the first of the year regarding the DNR Fishing Pier grant. At that time Huron Engineering will apply for permits and process for bids will begin.

## B) Fire Department Report

Fire Chief Hart provided handout and reported 19 runs during the month of October. Of the calls, 16 were medical, 2 power lines down and 1 stove fire. This brings their total to 218 runs this year to date compared to 198 runs last year.

Fire Chief Hart stated that Mark Hall, 911 director, said vaccines are coming next week. Hart is calling fire department personnel to see who would like the vaccine. Hart also provided handout regarding same.

Fire Chief Hart also addressed the board to purchase five 800 MHz radios for \$8,857.50 which would provide everyone on Sanborn Township Fire Department with a hand held radio. Liske made motion to purchase five 800 MHz radios for \$8,857.50. Eaton supported the motion. Motion carried.

### C) Ordinance Enforcement Report

Gauthier talked to Lori Champagne regarding 11792 US 23 South, Ossineke. Champagne stated she is trying to get ahold of Rich Prittie, Planning Commission Chairperson, to apply for a change of use regarding residence.

Further discussion took place regarding issuing zoning permits and zoning enforcement.
